### SECTION 4: First aid measures

#### 4.1. Description of first aid measures

### 4.2. Most important symptoms and effects, both acute and delayed

<b>General information</b>	The severity of the symptoms described will vary dependent on the concentration and the length of exposure. Chemical burns must be treated by a physician. Get medical attention immediately.

### 7.1. Precautions for safe handling

### 8.2. Exposure controls

#### Protective equipment



#### Appropriate engineering controls

Avoid inhalation of vapours. Provide adequate ventilation. All handling should only take place in well-ventilated areas. Observe any occupational exposure limits for the product or ingredients. In case of insufficient ventilation, wear suitable respiratory equipment.

#### Personal protection

All PPE must be kept in good condition. Polluted or damaged equipment must be replaced immediately.

#### Eye/face protection

Eyewear complying with an approved standard should be worn if a risk assessment indicates eye contact is possible. The following protection should be worn: Chemical splash goggles or face shield. Personal protective equipment that provides appropriate eye and face protection should be worn.

#### Hand protection

Chemical-resistant, impervious gloves complying with an approved standard should be worn if a risk assessment indicates skin contact is possible. It is recommended that gloves are made of the following material: Nitrile rubber. Polyvinyl chloride (PVC). The most suitable glove should be chosen in consultation with the glove supplier/manufacturer, who can provide information about the breakthrough time of the glove material. #### Respiratory protection

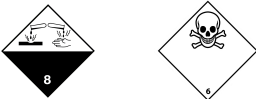
